BAC Resolution Declaring LCRQ and Recommending Award

WHEREAS, the PROVINCIAL SOCIAL WELFARE AND DEVELOPMENT OFFICE of the PROVINCIAL GOVERNMENT OF BOHOL made procurement under Purchase Request No. **2022-C-396** re: PROCUREMENT OF PACKED MEALS AND SNACKS FOR THE PARTICIPANTS OF THE CHILDREN'S MONTH CELEBRATION with an ABC of **P60,000.00**;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that REYNA'S THE HAVEN AND GARDENS FOOD CATERING SERVICES, INC. offered the lowest price quotation among the suppliers as reflected in the Abstract of Bids Proposals;
