WHEREAS, the BIDS AND AWARDS COMMITTEE passed BAC Resolution No. 22-1719 series of 2022 re: BAC Resolution Declaring 2nd Failure of Bidding and Recommending Procurement through Negotiated Mode; and was duly approved by the Honorable Governor, authorizing the use of the such Method of Procurement by the **BOHOL PROVINCIAL TOURISM OFFICE** in undertaking Procurement Request under PR No. 2022-C-276 re: PROCUREMENT OF CATERING SERVICES DURING THE TREE/ MANGROVE PLANTING with an ABC of ₱ 37,800.00;

WHEREAS, canvass of prices done in the course of the **Negotiated Method** of showed that **REYNA'S THE HAVEN AND GARDENS FOOD CATERING SERVICES, INC.** offered the lowest price quotations among the suppliers as reflected in the Abstract of Bids Proposals;
