BAC Resolution Declaring LCRQ and Recommending Award

WHEREAS, the **PROVINCIAL SOCIAL WELFARE AND DEVELOPMENT OFFICE** of the **PROVINCIAL GOVERNMENT OF BOHOL** made procurement under Purchase Request No. **2022-C-416** re: **PROCUREMENT OF PACKED MEALS AND SNACKS FOR THE PROVINCIAL CHILDREN'S CONGRESS AND PROVINCIAL CONGRESS (BMC-PEM & IPS)** with an ABC of **₱224,700.00**;
