BAC Resolution Recommending Procurement thru Negotiated Mode under Lease of Property and Venue, Declaring Lowest Calculated and Responsive Quotation and Recommending Award

WHEREAS, the <u>PROVINCIAL SOCIAL WELFARE AND DEVELOPMENT OFFICE</u> of the <u>PROVINCIAL GOVERNMENT OF BOHOL</u> made procurement under Purchase Request No. 2022-C-459 re: <u>PROCUREMENT OF ACCOMMODATION, MEALS AND SNACKS</u> FOR THE <u>PSWDO YEAR-END ASSESSMENT & EVALUATION AND OPERATIONAL PLANNING WORKSHOP</u> with an ABC of <u>P242,000.00</u>;
