BAC Resolution Recommending Procurement thru Negotiated Mode under Lease of Property and Venue, Declaring Lowest Calculated and Responsive Quotation and Recommending Award

WHEREAS, the **PROVINCIAL SOCIAL WELFARE AND DEVELOPMENT OFFICE** of the **PROVINCIAL GOVERNMENT OF BOHOL** made procurement under Purchase Request No. **2022-C-459** re: **PROCUREMENT OF ACCOMMODATION, MEALS AND SNACKS FOR THE PSWDO YEAR-END ASSESSMENT & EVALUATION AND OPERATIONAL PLANNING WORKSHOP** with an ABC of **₱242,000.00**;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement thru Lease of Property and Venue showed that **BEST WESTERN PLUS THE IVYWALL RESORT PANGLAO/ IWH BOHOL RESORT CORP.** offered the lowest price quotations among the suppliers as reflected in the Abstract of Bids Proposals;
