WHEREAS, the PROVINCIAL SOCIAL WELFARE AND DEVELOPMENT OFFICE of the PROVINCIAL GOVERNMENT OF BOHOL made procurement under Purchase Request No. 2022-C-397 re: PROCUREMENT OF PACKED MEALS, SNACKS AND VENUE FOR THE PARTICIPANTS OF THE GRAND SOCIALIZATION with an ABC of P60,000.00;




NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby **RESOLVE**, as it is hereby **RESOLVED**:




