BAC RESOLUTION RECOMMENDING THE USE OF NEGOTIATED PROCUREMENT THROUGH SMALL VALUE, DECLARING LOWEST CALCULATED AND RESPONSIVE QUOTATION AND RECOMMENDING APPROVAL

WHEREAS, the PROVINCIAL COOPERATIVE DEVELOPMENT OFFICE, of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. 2022-0599 re; Procurement of various Office Supplies, for use at the Provincial Cooperative Development Office, New Capitol Building, Tagbilaran City, Bohol. with an ABC of P 80,094.06;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that BAYONG'S CONSUMER GOODS TRADING offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotations;

WHEREAS, under Section 53.9 of the IRR of R.A. 9184 and upon careful examination, validation and verification of the accreditation and other pertinent documents of BAYONG'S CONSUMER GOODS TRADING including the price quotation offered, to determine its eligibility to transact business with the Provincial Government and the responsiveness of its quotation BAYONG'S CONSUMER GOODS TRADING has been found to be ELIGIBLE and its bid, RESPONSIVE;

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE, as it hereby RESOLVED:

- a.) To declare BAYONG'S CONSUMER GOODS TRADING as the supplier with the **LOWEST CALCULATED AND RESPONSIVE QUOTATION** for the **DELIVERY OF GOODS/SERVICES** under Negotiated Canvass No. 2022-0427;
- b.) To recommend award to BAYONG'S CONSUMER GOODS TRADING for the delivery of goods/services under Negotiated Canvass No. 2022-0427 in the amount of P 79,930.93;
- c.) To recommend for approval by the **HONORABLE GOVERNOR** of the **PROVINCIAL GOVERNMENT OF BOHOL** the foregoing findings.
