BAC RESOLUTION RECOMMENDING THE USE OF NEGOTIATED PROCUREMENT THROUGH SMALL VALUE, DECLARING LOWEST CALCULATED AND RESPONSIVE QUOTATION AND RECOMMENDING APPROVAL

WHEREAS, the OFFICE OF THE PROVINCIAL AGRICULTURIST, of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. 2022-0366 re; Procurement of various I.T. Equipment by the Office of the Provincial Agriculturist, New Capitol Compound, Tagbilaran City, with an ABC of P 114,000.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that B AND J COMPUTER SALES AND ELECTRONIC SERVICES, INC. offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotations;
