**BAC RESOLUTION RECOMMENDING THE USE OF NEGOTIATED PROCUREMENT THROUGH SMALL VALUE,
DECLARING LOWEST CALCULATED AND RESPOSIVE QUOTATION AND RECOMMENDING APPROVAL**

WHEREAS, the CLARIN COMMUNITY HOSPITAL, CLARIN, BOHOL, of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. - PHO - 2022 - 173 re: PROCUREMENT OF DESKTOP COMPUTER, LCD MONITOR & PRINTER with an ABC of P 220,000.00;


WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that BOHOL QUALITY CORPORATION offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Proposals,

WHEREAS, under Section 53.9 of the IRR of R.A. 9184 and upon careful examination, validation and verification of the accreditation and other pertinent documents of BOHOL QUALITY CORPORATION including the price quotation offered, to determine its eligibility to transact business with the Provincial Government and the responsiveness of its bid BOHOL QUALITY CORPORATION has been found to be ELIGIBLE and its bid, RESPONSIVE;

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE, as it hereby RESOLVED:



- b.) To recommend award to BOHOL QUALITY CORPORATION in the amount of ONE HUNDRED NINETY SEVEN THOUSAND FIVE HUNDRED TWENTY SEVEN PESOS ONLY (P 197,527.00) for the delivery of goods under Negotiated Canvass No. - PHO - 2022 - 095;
- c.) To recommend for approval by the HONORABLE GOVERNOR of the PROVINCIAL GOVERNMENT OF BOHOL the foregoing findings


