BAC RESOLUTION RECOMMENDING THE USE OF NEGOTIATED PROCUREMENT THROUGH SMALL VALUE, DECLARING LOWEST CALCULATED AND RESPOSIVE QUOTATION AND RECOMMENDING APPROVAL

WHEREAS, the CLARIN COMMUNITY HOSPITAL, CLARIN, BOHOL, of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. - PHO - 2022 - 173 re: PROCUREMENT OF DESKTOP COMPUTER, LCD MONITOR & PRINTER with an ABC of P 220,000.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that BOHOL QUALITY CORPORATION offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Proposals,
