WHEREAS, the OFFICE OF THE PROVINCIAL SOCIAL WELFARE AND DEVELOPMENT, TAMBLLOT STREET, TAGBILARAN CITY of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. 2022 – 0583 re: Purchase of Tires, Oil & Lubricants for service vehicle with plate no. 036410 Isuzu ELF & SJC – 182 Isuzu Crosswind with an ABC of P 145,582.00;





NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE, as it hereby RESOLVED:






