**BAC RESOLUTION RECOMMENDING THE USE OF NEGOTIATED PROCUREMENT THROUGH SMALL VALUE, DECLARING LOWEST CALCULATED AND RESPONSIVE QUOTATION AND RECOMMENDING APPROVAL**

WHEREAS, the PROVINCIAL ASSESSOR'S OFFICE, of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. 2022-0737 re: Procurement of Battery 11 - Plates & Tire 195R/14C for use at the Provincial Assessor's Office, New Capitol Compound, Tagbilaran City, with an ABC of P 64,660.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that 200 M AUTO REPAIR SHOP & PARTS offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotations;
