BAC Resolution Declaring LCRQ and Recommending Award

WHEREAS, the PROVINCIAL HEALTH OFFICE - BPDAC of the PROVINCIAL GOVERNMENT OF BOHOL made procurement under Purchase Request No. 2022-C-424 re: PROCUREMENT OF MEALS AND SNACKS FOR THE BPDAC YEAR-END ASSESSMENT with an ABC of **P57,000.00**;
