BAC RECOMMENDING PROCUREMENT THRU NEGOTIATED METHOD RESULTING FROM THE SECOND FAILURE OF BIDDING, DECLARING LCRQ AND RECOMMENDING AWARD

WHEREAS, the BIDS AND AWARDS COMMITTEE passed BAC Resolution No. 22-1758 series of 2022 re: BAC Resolution Declaring 2nd Failure of Bidding and Recommending Procurement through Negotiated Mode; and was duly approved by the Honorable Governor, authorizing the use of the such Method of Procurement by the **PROVINCIAL ENGINEER'S OFFICE** in undertaking Procurement Request under PR No. 2022-0053 re: **RENOVATION OF SPACES AT THE GROUND FLOOR OF THE CAPITOL FOR CONGRESSMEN'S OFFICES, PROVINCIAL CAPITOL, TAGBILARAN CITY** with an ABC of ₱ 283,910.59;


WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that **3N CONSTRUCTION AND SUPPLY** offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Proposals;




NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby **RESOLVES**, as it is hereby **RESOLVED**:
