WHEREAS, the BIDS AND AWARDS COMMITTEE passed BAC Resolution No. 22-1758 series of 2022 re: BAC Resolution Declaring 2^{md} Failure of Bidding and Recommending Procurement through Negotiated Mode; and was duly approved by the Honorable Governor, authorizing the use of the such Method of Procurement by the PROVINCIAL ENGINEER'S OFFICE in undertaking Procurement Request under PR No. 2022-0053 re: RENOVATION OF SPACES AT THE GROUND FLOOR OF THE CAPITOL FOR CONGRESSMEN'S OFFICES, PROVINCIAL CAPITOL, TAGBILARAN CITY with an ABC of P 283,910.59;
