BAC RESOLUTION RECOMMENDING THE USE OF NEGOTIATED PROCUREMENT THROUGH SMALL VALUE, DECLARING LOWEST CALCULATED AND RESPONSIVE QUOTATION AND RECOMMENDING APPROVAL

WHEREAS, the <u>TEODORO B. GALAGAR DISTRICT HOSPITAL, JAGNA, BOHOL</u> of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under <u>Purchase Requests No. - PHO - 2022 - 425</u> re: <u>PROCUREMENT OF VARIOUS ELECTRICAL MATERIALS FOR THE IMPROVEMENT OF THE ELECTRICAL SYSTEM AT THE OPD/ER AND ST. MICHAEL BUILDING</u> with an ABC of <u>P 652,713.00</u>.

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that <u>BUSAY</u> <u>HARDWARE AND CONSTRUCTION SUPPLY</u> offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Proposals,

WHEREAS, under Section 53.9 of the IRR of R.A. 9184 and upon careful examination, validation and verification of the accreditation and other pertinent documents of <u>BUSAY HARDWARE AND CONSTRUCTION SUPPLY</u> including the price quotation offered, to determine its eligibility to transact business with the Provincial Government and the responsiveness of its bid <u>BUSAY HARDWARE AND CONSTRUCTION SUPPLY</u> has been found to be ELIGIBLE and its bid, RESPONSIVE;

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE, as it hereby RESOLVED:

- b.) To recommend award to <u>BUSAY HARDWARE AND CONSTRUCTION SUPPLY</u> for the delivery of goods under <u>Negotiated Canvass No. PHO 2022 244</u>, in the amount of <u>P 651,699.00</u>;
- c.) To recommend for approval by the **HONORABLE GOVERNOR** of the **PROVINCIAL GOVERNMENT OF BOHOL** the foregoing findings
