WHEREAS, the **TEODORO B. GALAGAR DISTRICT HOSPITAL, JAGNA, BOHOL** of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. - PHO - 2022 - 425 re: **PROCUREMENT OF VARIOUS ELECTRICAL MATERIALS FOR THE IMPROVEMENT OF THE ELECTRICAL SYSTEM AT THE OPD/ER AND ST. MICHAEL BUILDING** with an ABC of **P 652,713.00**.





NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby **RESOLVE**, as it hereby **RESOLVED**:






