INVITATION TO BID FOR PROCUREMENT OF GOODS/SERVICES

The Provincial Government of Bohol, through the Bids and Awards Committee for CY 2014 intends to apply the sum of **ONE HUNDRED SEVENTY NINE THOUSAND SIXTY PESOS (P 179,060.00)** being the Approved Budget for the Contract (ABC) to payments under the contract for Procurement of Goods/Services for **PURCHASE OF VARIOUS MEDICINES FOR USE AT THE TEODORO B. GALAGAR DISTRICT HOSPITAL, JAGNA, BOHOL** for Project Reference No. **PHO-062**. Bids received in excess of the ABC shall be automatically rejected at bid opening.

The Provincial Government of Bohol now invites bids for **PURCHASE OF VARIOUS MEDICINES**. Delivery of the Goods/Services is required within **5 DAYS** after receipt of the Contract Agreement. Bidders should have completed within the last three years from the date of submission and receipt of bids, a contract similar to the project with an amount of at least fifty percent (50%) of the Approved Budget for the Contract. The description on an eligible bidder is contained in the Bidding Documents, particularly, in Section 11, Instruction to Bidders.

Bidding will be conducted through open competitive bidding procedures using a non-discretionary “pass/fail” criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the “Government Procurement Reform Act”.

Bidding is open to all interested bidders, whether local or foreign, subject to the conditions for eligibility provided in the IRR of RA 9184.

Interested bidders may obtain further information from the Provincial Government of Bohol and inspect the Bidding Documents at the address given below during 8:00 AM – 5:00 PM Monday to Friday only except holidays.

A complete set of Bidding Documents may be purchased by interested Bidders on **MAY 4 - 14, 2014** from the address below and upon payment of a non-refundable fee for the Bidding Documents in the amount of **P 150.00** at the Provincial Treasurer’s Office, Capitol Complex, Tagbilaran City.

It may also be downloaded free of charge from the website of the Procuring Entity www.bohol.gov.ph, provided that Bidders shall pay the non refundable fee for the Bidding Documents not later than the submission of their bids.

The Government of Bohol will hold a Pre-Bid Conference on **N/A** at the BAC Conference Room, PPMU Office, which shall be open to all interested parties.

Bids must be delivered to the address below on or before **MAY 14, 2014 @ 9:30 A.M.** All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in the ITB Clause 18.

Bid opening shall be on **MAY 14, 2014 @ 9:30 A.M @ the PPMU Office**, Tagbilaran City. Bids will be opened in the presence of the Bidders’ representatives who choose to attend at the address below. Late Bids shall not be accepted.

The Provincial Government of Bohol reserves the right to accept or reject any bid, to annul the bidding process and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
