



BAC Resolution Recommending the Use of Negotiated Procurement through Small Value, Declaring Lowest Calculated and Responsive Quotation and Recommending Approval

WHEREAS, the PROVINCIAL MOTOR POOL OFFICE of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. 2019-0741; re; Procurement of Starter Motor Assy., Hydraulic Hose Assy., Empty Drum & Engine Oil Filters for use at Provincial Motor Pool Office, Tagbilaran City. with an ABC of P 90,730.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that CARE AUTOHAUS offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotations;
