WHEREAS, the BIDS AND AWARDS COMMITTEE passed BAC Resolution No. 19-0980 series of 2019 re: BAC Resolution Declaring 2nd Failure of Bidding and Recommending Procurement through Negotiated Mode; and was duly approved by the Honorable Governor, authorizing the use of the such Method of Procurement by the **PROVINCIAL GENERAL SERVICES OFFICE** in undertaking Procurement Request under PR No. 2019-0789 re: Procurement of Oil Filter, Brake fluids, ATF, Engine Oil & Coolant for the Service Vehicles at the Provincial General Services Office, Tagbilaran City. with an ABC of ₱ 94,050.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that **GJ CAR CARE & PARTS CENTER** offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotation;
