WHEREAS, the BIDS AND AWARDS COMMITTEE passed BAC Resolution No. 19-0244 series of 2020 re: BAC Resolution Declaring 2nd Failure of Bidding and Recommending Procurement through Negotiated Mode; and was duly approved by the Honorable Governor, authorizing the use of the such Method of Procurement by the OFFICE OF THE AGRICULTURIST in undertaking Procurement Request under PR No. 2019-0860 re: Procurement of Rice Color Sorter & Rice Mill to Increase Farm Mechanization Level in the Province of Bohol thru Enhancement & Creation of Provincial farm Machinery with an ABC of P1,250,000.00;

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVES, as it is hereby RESOLVED:


