



BAC Resolution Recommending the Use of Negotiated Procurement through Small Value, Declaring Lowest Calculated and Responsive Quotation and Recommending Approval

WHEREAS, the GOVERNOR OFFICE-SPECIAL PROJECT SECTION of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. 2020-0054; re; Procurement of Plaques (Fiber Glass) for the Recognition for Partner Agencies, Visiting Dignitaries Local & Foreign Among Others, by the Office of the Governor - Special Project Section, New Capitol Compound, Tagbilaran City. with an ABC of P 375,000.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that ADS & PRINTS REPUBLIQ offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotations;

WHEREAS, under Section 53.9 of the IRR of R.A. 9184 and upon careful examination, validation and verification of the accreditation and other pertinent documents of ADS & PRINTS REPUBLIQ including the price quotation offered, to determine its eligibility to transact business with the Provincial Government and the responsiveness of its bid ADS & PRINTS REPUBLIQ has been found to be ELIGIBLE and its bid, RESPONSIVE;
