



BAC Resolution Declaring 2nd Lowest Complying and Responsive Bid and Recommending Approval

WHEREAS, the PROVINCIAL GOVERNMENT OF BOHOL caused the posting of ADVERTISEMENT at PhilGEPS, PGB Website and at three (3) conspicuous places in the premises of the Provincial Capitol Complex, Tagbilaran City for the Invitation to Apply for Eligibility and to Bid for the Project, hereunder described:

WHEREAS, during the holding of the competitive public bidding for the above procurement request, **TWO (2)** Bidder/s bought the BID Documents in the actual conduct of public bidding namely;

BOHOL QUALITY CORPORATION & LEBAK SUSTAINABLE ORGANIC AGRICULTURE MPC

WHEREAS, BOHOL QUALITY CORPORATION was awarded being the Lowest Calculated and Responsive Bid (refer to BAC Resolution No. 20-0229) and was issued with Purchase Order under P.O. No. 2020-297 dated May 26, 2020;

WHEREAS, BOHOL QUALITY CORPORATION, sent a letter dated June 4, 2020, waiving its right to deliver for item no. 1 (commercial rice) due to low production and will entail a longer period of time of its availability if they will proceed with the delivery;

WHEREAS, in the detailed evaluation of bids during its bid opening on March 25, 2020, **LEBAK SUSTAINABLE ORGANIC AGRICULTURE MPC** was the Second Lowest Calculated Bid as Read and subsequently a post qualification process was initiated to the later;

WHEREAS, upon the conduct of post qualification by the Technical Working Group, **LEBAK SUSTAINABLE ORGANIC AGRICULTURE MPC** met the required legal, technical and financial requirements for the said project

WHEREAS, upon recommendation by the Technical Working Group and verification, validation and ascertaining of all statements made and documents submitted by **LEBAK SUSTAINABLE ORGANIC AGRICULTURE MPC** the bidder declared as the **SECOND LOWEST CALCULATED BID,** successfully passed the Post Qualification process, thus the Committee now considered its bid as the **LOWEST CALCULATED and RESPONSIVE BID** for item no. 1 for the said project;

NOW THEREFORE, We the Members of the Bids and Awards Committee, hereby RESOLVE, as it is hereby RESOLVED:

- a) To declare **LEBAK SUSTAINABLE ORGANIC AGRICULTURE MPC** as the **LOWEST CALCULATED AND RESPONSIVE BID** PROCUREMENT OF COMMERCIAL RICE, FOR BARANGAY HEART AGRI/MEDICAL/DENTAL CARAVAN 2020/PROTEAM DEPLOYMENT under Project Reference No. **A-20-0084;**
- b) To recommend for Award to **LEBAK SUSTAINABLE ORGANIC AGRICULTURE MPC** for the PROCUREMENT OF COMMERCIAL RICE, FOR BARANGAY HEART AGRI/MEDICAL/DENTAL CARAVAN 2020/PROTEAM DEPLOYMENT in the amount of **P 1,368,000.00;**
- c) To recommend for approval by the **HONORABLE GOVERNOR** of the **PROVINCIAL GOVERNMENT OF BOHOL** the foregoing findings;
