WHEREAS, the **GOVERNOR OFFICE-SPECIAL PROJECT SECTION** of the **PROVINCIAL GOVERNMENT OF BOHOL** made procurement of goods under Purchase Requests No. 2020-0055; re; Procurement of Plaques for use at the Office of the Governor - SPS, New Capitol Compound, Tagbilaran City. with an ABC of P 370,000.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that **ADS & PRINTS REPUBLIQ** offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotations;


