Declaring 2<sup>nd</sup> Failure of Bidding and Recommending Award

WHEREAS, the BIDS AND AWARDS COMMITTEE passed BAC Resolution No. 19-02367 series of 2019 re: BAC Resolution Declaring 2<sup>nd</sup> Failure of Bidding and Recommending Procurement through Negotiated Mode; and was duly approved by the Honorable Governor, authorizing the use of the such Method of Procurement by the PROVINCIAL GENERAL SERVICES OFFICE in undertaking Procurement Request under PR No. 2019-0120, 2019-0123 & 2019-0130 re: Procurement of Various Hardware, Plumbing & Construction Supplies for the use at Provincial General Services Office, Tagbilaran City. with an ABC of ₱ 1,118,896.44

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that BOHOL PEOPLE'S LUMBER CORPORATION offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotation;
