WHEREAS, the BIDS AND AWARDS COMMITTEE passed BAC Resolution No. 19-1196 series of 2020 re: BAC Resolution Declaring 2nd Failure of Bidding and Recommending Procurement through Negotiated Mode; and was duly approved by the Honorable Governor, authorizing the use of the such Method of Procurement by the OFFICE OF THE PROVINCIAL ENGINEER in undertaking Procurement Request under PR No. 2019-0913 re: Procurement of Rescue Truck & Van Type Vehicle with an ABC of ₱ 5,200,000.00
