

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE, as it hereby RESOLVED:

- b.) To recommend award to 200M AUTO REPAIR SHOP AND PARTS in the amount of ONE HUNDRED SIX THOUSAND FIVE HUNDRED TWENTY FIVE PESOS ONLY (P 106,525.00) for the delivery of goods under Negotiated Canvass No. - PHO - 2020 - 089;
- c.) To recommend for approval by the HONORABLE GOVERNOR of the PROVINCIAL GOVERNMENT OF BOHOL the foregoing findings






