WHEREAS, the PROVINCIAL ENGINEER'S OFFICE of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Request No. 2020-0339; re: Procurement of Hardware & Construction Supplies for the General Repair of Sapang Dako Bridge at Monte Video, Carmen, Bohol, by the Provincial Engineer's Office, New Capitol Compound, Tagbilaran City. with an ABC of P 337,825.00;






