


NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE, as it hereby RESOLVED:

- b.) To recommend award to **ST. JUDE PRESS MARKETING AND SUPPLIES** in the amount of **SIXTY FIVE THOUSAND FIVE HUNDRED FORTY PESOS ONLY (P 65,540.00)** for the delivery of goods under Negotiated Canvass No. - PHO - 2020 - 073;
- c.) To recommend for approval by the **HONORABLE GOVERNOR** of the **PROVINCIAL GOVERNMENT OF BOHOL** the foregoing findings




