WHEREAS, the OFFICE OF THE PROVINCIAL AGRICULTURIST, of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. 2020-0299; re; Procurement of Plaques, Frames & Streamers for use During the Gulayan sa Paaralan Program & Bahay Kubo FAITH HOPE Awarding Ceremony, by the Office of the Provincial Agriculturist, New Capitol Compound, Tagbilaran City. with an ABC of P 108,965.73;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that BLUE ARROW SIGNS & PRINTS INC. offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotations;
