



BAC Resolution Recommending the Use of Negotiated Procurement through Small Value, Declaring Lowest Calculated and Responsive Quotation and Recommending Approval

WHEREAS, the **OFFICE OF THE SP - BOARD MEMBER DIONISIO VICTOR A. BALITE** of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Request No. 2020-0346; re; Procurement of Storage Battery, Engine Oil, Oil Treatment & Vehicle Spare Parts with labor for the Service Vehicle Strada Assigned at the Office of SP - Board Member Dionisio Victor A. Balite, New Capitol Compound, Tagbilaran City. with an ABC of P 117,430.00;
