BAC Resolution Recommending the Use of Negotiated Procurement through Small Value, Declaring Lowest Calculated and Responsive Quotation and Recommending Approval

WHEREAS, the OFFICE OF THE SP – BOARD MEMBER DIONISIO VICTOR A. BALITE of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Request No. 2020-0346; re; Procurement of Storage Battery, Engine Oil, Oil Treatment & Vehicle Spare Parts with labor for the Service Vehicle Strada Assigned at the Office of SP - Board Member Dionisio Victor A. Balite, New Capitol Compound, Tagbilaran City. with an ABC of P 117,430.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that <u>TAGBILARAN CITY</u> <u>TYRE SALES & SERVICE CENTER</u> offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotations;
