WHEREAS, the BIDS AND AWARDS COMMITTEE passed BAC Resolution No. 20-0360 series of 2020 re: BAC Resolution Declaring 2nd Failure of Bidding and Recommending Procurement through Negotiated Mode; and was duly approved by the Honorable Governor, authorizing the use of the such Method of Procurement by the OFFICE OF THE PROVINCIAL AGRICULTURIST/RASS in undertaking Procurement Request under PR No. 2020-0031 re: PROCUREMENT OF LABOR, MATERIALS & OTHER MISCELLANEOUS EXPENSES FOR THE CONSTRUCTION OF FARM MACHINERY WAREHOUSE & ENHANCEMENT OF LABORATORY & PRODUCTION FACILITIES FOR VERMICULTURE & BIO CONTROL AGENTS & ENTHOMOPATHOGENS with an ABC of ₱ 2,000,000.00;
