WHEREAS, upon the conduct of post qualification by the Technical Working Group, **K-9 VETERINARY SERVICES AND P & J AGRICULTURAL TRADING, INC.** met the required legal, technical and financial requirements for the said project;

WHEREAS, upon recommendation by the Technical Working Group and verification, validation and ascertaining of all statements made and documents submitted by **K-9 VETERINARY SERVICES AND P & J AGRICULTURAL TRADING, INC.**, the bidders declared as the **LOWEST CALCULATED BID**, successfully passed the Post Qualification process, thus the Committee now considered its bid as the **LOWEST COMPLYING and RESPONSIVE BID** for the said project;
