



**BAC Resolution Recommending the Use of Negotiated Procurement through Small Value, Declaring Lowest Calculated and Responsive Quotation and Recommending Approval**

WHEREAS, the OFFICE OF THE PROVINCIAL AGRICULTURIST of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Request No. 2020-0416; re: Procurement of Engine Oil, Oil Filter, Fluids, Coolant & Various Vehicle Spareparts for use to Repair and Maintenance of Service Vehicles with Plate Nos. NQO 804, SKN-830 and SFR-252 Assigned at the Office of the Provincial Agriculturist, New Bohol Provincial Capitol Building, Cogon District, Tagbilaran City with an ABC of P 166,752.20;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that GJ CAR CARE AND PARTS CENTER offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotations;

WHEREAS, under Section 53.9 of the IRR of R.A. 9184 and upon careful examination, validation and verification of the accreditation and other pertinent documents of GJ CAR CARE AND PARTS CENTER including the price quotation offered, to determine its eligibility to transact business with the Provincial Government and the responsiveness of its bid GJ CAR CARE AND PARTS CENTER has been found to be ELIGIBLE and its bid, RESPONSIVE;

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE, as it hereby RESOLVED:

- a.) To declare GJ CAR CARE AND PARTS CENTER as the bidder with the **LOWEST CALCULATED AND RESPONSIVE BID** for the **DELIVERY OF GOODS/SERVICES** under Negotiated Canvass No. 2020- 0299;
- b.) To recommend award to GJ CAR CARE AND PARTS CENTER for the delivery of goods/services under Negotiated Canvass No. 2020-0299 in the amount of P 166,621.00;
- c.) To recommend for approval by the **HONORABLE GOVERNOR** of the **PROVINCIAL GOVERNMENT OF BOHOL** the foregoing findings.
