



BAC Resolution Recommending the Use of Negotiated Procurement through Small Value, Declaring Lowest Calculated and Responsive Quotation and Recommending Approval

WHEREAS, the **PROVINCIAL ACCOUNTING OFFICE**, of the **PROVINCIAL GOVERNMENT OF BOHOL** made procurement of goods under Purchase Requests No. **2020-0382**; re; **Procurement of various Office and Janitorial Supplies for use at the Provincial Accounting Office, Bohol Provincial Capitol Building, Cogon District, Tagbilaran City** with an ABC of **P 76,324.43**;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that **3 MSG ENTERPRISES** offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotations;

WHEREAS, under Section 53.9 of the IRR of R.A. 9184 and upon careful examination, validation and verification of the accreditation and other pertinent documents of **3 MSG ENTERPRISES** including the price quotation offered, to determine its eligibility to transact business with the Provincial Government and the responsiveness of its bid **3 MSG ENTERPRISES** has been found to be **ELIGIBLE** and its bid, **RESPONSIVE**;
