WHEREAS, the OFFICE OF THE PROVINCIAL AGRICULTURIST, of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Request No. 2020-0305; re; Procurement of Desktop Computer for the use at the Office of the Provincial Agriculturist, New Capitol Compound, Tagbilaran City, with an ABC of P 63,200.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that B&J COMPUTER AND ELECTRONICS SERVICES offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotations;
