WHEREAS, the **PROVINCIAL GENERAL SERVICES OFFICE** of the **PROVINCIAL GOVERNMENT OF BOHOL** made procurement of goods under Purchase Requests No. **2020-0590**; re; **Procurement of Labor & Materials for Check-up, Repair, Cleaning, Installation and Testing of Blowers, Provincial General Services Office, New Bohol Provincial Capitol Building, Cogon District, Tagbilaran City.** with an ABC of **P 194,880.00**;
