



BAC Resolution Recommending the Use of Negotiated Procurement through Small Value, Declaring Lowest Calculated and Responsive Quotation and Recommending Approval

WHEREAS, the PROVINCIAL ASSESSOR'S OFFICE of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. 2020-0262; re; Procurement of Inverter/Split Type Air Conditioning Unit for use at the Provincial Assessor's Office, New Capitol Site, Tagbilaran City with an ABC of P 100,000.00;

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby **RESOLVE**, as it hereby **RESOLVED**:




