**WHEREAS**, the **BOHOL INVESTMENT PROMOTION CENTER** of the **PROVINCIAL GOVERNMENT OF BOHOL** made procurement of goods under Purchase Requests No. 2020-0178, re; Procurement of the Air Conditioning Unit for use at Bohol Investment Promotion Center, Capitol Complex, Tagbilaran City. with an ABC of P 120,000.00;




