



BAC Resolution Recommending the Use of Negotiated Procurement through Small Value, Declaring Lowest Calculated and Responsive Quotation and Recommending Approval

WHEREAS, the **GOVERNOR'S OFFICE – CENTER FOR CULTURE & ARTS DEVELOPMENT** of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. **2020-0798; Procurement of Various Hardware & Painting for the Installation & Fabrication of Giant Belen in the Provincial Capitol by the Office of the Governor – Center for Culture & Arts Development, New Capitol Compound, Tagbilaran City.** with an ABC of **P 252,461.00;**

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that **GMEGS GENERAL MERCHANDISE** offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotations;
