WHEREAS, the OFFICE OF THE PROVINCIAL VETERINARIAN of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. 2020-0182; re; Procurement of Inverter Type Air Conditioning Unit for the use at the Office of the Provincial Veterinarian, Tagbilaran City. with an ABC of P 213,000.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that SAMMY'S AIRCONDITIONING & REF. SERVICES AND REPAIR SHOP offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotations;

WHEREAS, under Section 53.9 of the IRR of R.A. 9184 and upon careful examination, validation and verification of the accreditation and other pertinent documents of SAMMY'S AIRCONDITIONING & REF. SERVICES AND REPAIR SHOP including the price quotation offered, to determine its eligibility to transact business with the Provincial Government and the responsiveness of its bid SAMMY'S AIRCONDITIONING & REF. SERVICES AND REPAIR SHOP has been found to be ELIGIBLE and its bid, RESPONSIVE;

- c.) To recommend for approval by the **HONORABLE GOVERNOR** of the **PROVINCIAL GOVERNMENT OF BOHOL** the foregoing findings.




