

BAC Resolution Recommending the Use of Alternative Mode of through Direct Contracting, Declaring Single Calculated and Responsive Bid and Recommending Approval

WHEREAS, the Chief of the PROVINCIAL HEALTH OFFICE, NEW CAPITOL BUILDING, COGON DISTRICT, TAGBILARAN CITY of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of the goods under Purchase Request No. - PHO - 2020 - 325 re: PROCUREMENT O/I/ U ASSEMBLY, DRUM KIT FOR INEO, DEVELOPER, TRANSFER ROLLER & FUSING UNIT with an ABC of P 73,490.00;

  - b) To declare COPYLANDIA OFFICE SYSTEMS CORPORATION as the sole distributor of said products in the amount of P 73,490.00; thus recommendation for award is hereby conferred to; under DC No. - PHO - 2020 - 061;
  - c) To recommend approval by the HONORABLE GOVERNOR of the PROVINCIAL GOVERNMENT OF BOHOL the foregoing findings


