WHEREAS, the OFFICE OF THE PROVINCIAL VETERINARIAN of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Request No. 2020-0871; re: Procurement of Engine Oil, Vehicle Spare Parts & Labor for the Maintenance of Vehicle with Plate No. SEZ - 400 & SEZ - 590, by the Office of the Provincial Veterinarian, New Capitol Compound, Tagbilaran City, with an ABC of P 164,670.00;





- c.) To recommend for approval by the HONORABLE GOVERNOR of the PROVINCIAL GOVERNMENT OF BOHOL the foregoing findings.






