**CONTRACT AGREEMENT**

KNOW ALL MEN BY THESE PRESENTS:

THIS AGREEMENT, made this 15th day of November, 2020 between Provincial Government of Bohol with office address at the Provincial Capitol, Tagbilaran City, Bohol, represented herein by **ATTY. ARTHUR C. YAP**, Provincial Governor, hereinafter referred to as the "ENTITY"

and

**C. JANSEN CONST. AND GENERAL MERCHANDISE** with the office address at Poblacion, Danao, Bohol represented herein by **MS. CHERYL JANSEN C. VITOR** Proprietor, hereinafter referred to as the "CONTRACTOR".

WHEREAS, the Entity is desirous that the CONTRACTOR execute the works under the **CONSTRUCTION OF PROCESSING BUILDING** of the "Bohol Virgin Coconut Oil Production and Marketing Enterprise", hereinafter referred to as the "WORKS," and the ENTITY has accepted the Quotation of the CONTRACTOR, as submitted and opened, for the execution and completion of the WORKS for the total contract Price of **Three Million Seven Hundred Thirteen Thousand One Hundred Thirty-Nine & 87/100 Pesos ( Php. 3,713,139.87)**.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Contract Agreement, words and expressions shall have the same meaning as are respectively assigned to them in the Terms and Conditions hereinafter referred to.
2. The following documents shall be attached, deemed to form, and be read and construed as part of this agreement, to wit:

- (a) Filled- up Request for Quotation (RFQ);
- (b) Bill of Quantities (BOQ) including the detailed computation of costs per item of work;
- (c) Arithmetic Calculation of the Quotation;
- (d) Terms and Conditions;
- (e) Plans and Specifications;
- (f) Addenda and/or Supplemental, if any;
- (g) Eligibility, Technical and Financial Documents;
- (h) Notice of Award;
- (i) Performance Security; and
- (j) Construction Safety and Health Program approved by the Department of Labor and Employment.

3. In consideration of the payments to be made by the ENTITY to the CONTRACTOR as hereinafter mentioned, the CONTRACTOR hereby covenants with the ENTITY to execute and complete the WORKS and remedy any defects therein in conformity with the provisions of this Contract Agreement in all respect.

4. The ENTITY hereby covenants to pay the CONTRACTOR in consideration of the execution and completion of the WORKS and the remedying of defects wherein, the Contract Price or such other sum as may become payable under the provisions of this Contract Agreement at the times and in the manner prescribed by this Contract Agreement.

5. The Duration of the WORKS is 229 calendar days.
