



BAC Resolution Recommending the Use of Negotiated Procurement through Small Value, Declaring Lowest Calculated and Responsive Quotation and Recommending Approval

WHEREAS, the **BOHOL DISTRICT JAIL** of the **PROVINCIAL GOVERNMENT OF BOHOL** made procurement of goods under Purchase Requests No. **2020-0867**; re; **Procurement of Service Vehicle as Prisoner's Van for the use of Bohol District Jail, Tagbilaran City, Bohol** with an ABC of **P 118,180.00**;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that **GJ CAR CARE AND PARTS CENTER** offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotations;
