WHEREAS, the GOVERNOR'S OFFICE of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Request No. 2020-167 re: Procurement of SARS - CoV 2 IgG/IgM Cassette Rapid Test for use Bohol Provincial Health Office, Tagbilaran City, to address the Ongoing threat of COVID-19, Provincial Health Office, New Capitol Compound, Tagbilaran City, with and ABC of P 4,000,000.00;
