WHEREAS, the CANDIJAY COMMUNITY HOSPITAL, CANDIJAY, BOHOL of the **PROVINCIAL GOVERNMENT OF BOHOL** made procurement under Purchase Request No. PHO – 2020 386 re: PROCUREMENT OF MEDICAL SUPPLIES with an ABC of ₱ 1,394,400.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement – Emergency Cases showed that DEXTEL TRADING offered the single price quotation as reflected in the Abstract of Bids Proposals;

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby **RESOLVE**, as it is hereby **RESOLVED**:






