



**BAC Resolution Recommending the Use of Negotiated Procurement through Small Value, Declaring Lowest Calculated Responsive Quotation and Recommending Approval**

WHEREAS, the **PROVINCIAL MOTOR POOL OFFICE** of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. 2020-0853; re; **Procurement of Tires for the Dump Trucks at Provincial Motor Pool Office, New Capitol Compound, Tagbilaran City.** with an ABC of P 488,750.00.

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE, as it hereby RESOLVED:




