

BAC Resolution Recommending Procurement thru Negotiated Method Resulting from the Second Failure of Bidding, Declaring LCRQ and Recommending Award

WHEREAS, the BIDS AND AWARDS COMMITTEE passed BAC Resolution No. 20-0130-A series of 2020 re: BAC Resolution Declaring 2nd Failure of Bidding and Recommending Procurement through Negotiated Mode; and was duly approved by the Honorable Governor, authorizing the use of the such Method of Procurement by the OFFICE OF THE PROVINCIAL AGRICULTURIST in undertaking Procurement Request under PR No. 2020-0064 re: Procurement of Organic Fertilizer/Soil Conditioner, by the Office of the Provincial Agriculturist, New Capitol Site, Tagbilaran City, with an ABC of P 418,000.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that LEZAR TRADING offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotation;



- b). To recommend award to LEZAR TRADING in the amount of P 334,890.00 of delivery of goods/services under Negotiated Canvass No. 2020-0113 (2nd Failure);
- c). To recommend for approval by the HONORABLE GOVERNOR of the PROVINCIAL GOVERNMENT OF BOHOL the foregoing findings.






